They serve all of Marshall County. Equips people of Sierra Leone w/ educational, micro- financial, spiritual and physical tools needed to cultivate independence in life and to minister to their countrymen. Three major focus areas now: individual development through vocational training and micro financing of cottage industry; community development through agricultural training and development, plus pastoral training and church planting. Medical mission support has been added to their work. Bolands provide excellent communication regarding this growing mission in deeply Muslim territory.	\$5000 General support.
